NOW OPEN: Grant for businesses to install electric vehicle chargers

Do you want to add a public charging station to your commercial property? Central Saanich's new *Business Electric Vehicle (EV) Charger Grant* offers up to 50 per cent of the overall cost of a Level 2 charging station (to a maximum of \$5,000 rebate per station).

Businesses in the communities of Central Saanich, Tsartlip and Tsawout First Nations, as well as not-for-profit organizations that provide a public service within the District are encouraged to apply.

The District of Central Saanich will publicize the location of businesses with charging stations.

Participants are encouraged to combine this grant with other rebates that may be available. Participating businesses may also choose to charge drivers for the time they spend hooked up to the charger.
